RevCon Technology Group will furnish and install all necessary devices, equipment, materials, hardware and wiring to complete the transition to Payment Express P2PE EMV Credit Card Processing at the Holley Court Garage. The following is the equipment listing and related installation costs.

Installation

Remove components attached to front door panels and detach doors from hinges or slides; \$35,900.00
 install new steel EMV door panels to hinges and door slides; reinstall all components onto
 each door panel; install new pre-programmed EMV contact chip readers to frames with new
 wiring harness; install new custom graphic panels to faces of the new door panels; install
 new EMV contactless NFC readers onto panel fronts; install new LPR cameras, Zebra
 scanners and controllers; install new barrier gate arms and necessary vehicle detector loops;
 install all new dedicated cable and connect all to the existing upgraded IP network; perform
 all system programming to accept new devices; test for satisfactory functionality and
 recommission each terminal; provide key personnel training.

Customer Responsibilities

- Provide and maintain a *managed* internet connection with a minimum up/down bandwidth of 50 mbps.
- Create a new merchant account with Payment Express (Windcave) with new merchant and terminal IDs for credit card processing.

RevCon shall provide a two-year warranty on the PARCS devices and on our workmanship. **The existing Service Agreement will decrease to \$36,000.00 annually during the warranty period and a new Service Agreement will be offered prior to the end of the warranty period.** Work will be scheduled upon receipt of the deposit payment. Terms are as follows: **A deposit payment of \$80,000.00 plus 50% of any elected options is due at acceptance** per manufacturers' requirements; **a milestone payment of \$60,720.00 plus the balance of any elected options is due prior to equipment shipment** per manufacturers' requirements **with the balance of \$15,700.00 due at completion.**
